Agenda Item 6 – Update on Blood Lead Level Clinic

DD provided a brief background of his position with Hunter New England Health (HNEH). He thanked the Chair and CRG for the work they put into promoting the Blood Lead Level Clinics. He also acknowledged the work of HNEH.

Susan Thomas (ST) provided a presentation of the results of the Blood Lead Level Clinic. HNEH are awaiting final recommendations from the Chief Health Officers' Lead Reference Group. When the recommendations are received they will be distributed to the CRG, community via a letter box drop and made available on their website.

ST also advised that additional clinics will be conducted each month and will confirm the date and times with the CRG.
