Agenda Item 5 – LAS Presentation

Adam Gilligan (AG) updated the CRG on progress of the Lead Expert Working Group's (LEWG) report to Government. He advised the LEWG held a workshop on 2 February, which focussed on reviewing the LAS against the National Environment Protection Measure. The group have also allocated responsibility for drafting sections of the report to Government, and first drafts are due by 1 April 2016. These will be then be collated and edited, then distributed to the CRG for comment. There is a consultation chapter which AG has drafted and distributed to the CRG for comment, with further information to be added from Emma Hale's (EM) list of issues, and from GP's visit to the USA.

The Literature Review tender process has almost been finalised, with the report due in May 2016.

AG advised that a comprehensive presentation on the Literature Review and Report to Government will be provided to the CRG.

Lengthy discussions continued on the adequacy of and the different views of the LAS.

Agenda Item 6 – Issues/Concerns – How they were addressed – for Webpage

EH provided a list of key issues of concern raised by the CRG. Each member of the CRG will review the list and provide feedback to the EPA by mid April. The list will then be published on the website and will be included in the LEWG's report to Government.

Agenda Item 7 – General Business

Black Slag

LMCC advised that the sites where black slag has been found near Tredinnick Oval on the Esplanade at Speers Point Park and the Art Gallery foreshore will be remediated by the end of this financial year.

Development Applications

Lengthy discussions proceeded regarding the difficulties and inequities when submitting a Development Application to LMCC. All agreed that there needed to be consistency in the planning process throughout all of the Lake Macquarie LGA. LMCC also advised that Council Planners were being trained to deal with applications submitted under LAS.

Leaching

The question of whether lead in soil will leach out over time was raised. AG advised that research (especially by Tony Morrison) has shown that slag in soil is leachable, particularly in saline or acidic conditions. More research needs to be carried out in this area to understand the extent of the issue over time, and its relationship to water quality nearby.
