#### Step 2: Your **site**.

Tell us a few simple details about your business type and size.

#### Step 3: Your **waste**.

Tell us about your waste and recycling bins and what materials are in your bins.

#### Step 4: Your **action plan**.

Create your action plan. We will identify the Top 3 recommended actions for your business or you can create your own action. You can select and assign actions to reduce your waste.

#### **Monitor** your improvements.

Keep checking in regularly to track actions you have taken and track how much waste you have reduced. Compare against other similar businesses in your region.



## Bin Trim Equipment Rebates

Businesses who complete their own assessment using the Bin Trim Business app may qualify for rebates to contribute to the cost of purchasing or leasing new equipment and technologies that avoid, reduce, reuse or recycle your waste.

Phone and email support for rebate applications is available through the Bin Trim Business app.

### How much funding is available?

Eligible businesses can apply for a rebate up to a maximum of \$50,000 or 50% of the purchase price of equipment.
