

Statutory declaration for application under mutual recognition

If you are seeking to apply for:

- a NSW radiation licence to use regulated material (radiation apparatus, sealed source devices or radioactive substances)

or

- accreditation as a consulting radiation expert

under mutual recognition legislation, you must submit this statutory declaration with the relevant application.

Before you complete this declaration, please read [Guideline for the Operation of Part 3 of the Mutual Recognition Legislation](#).

A person making a false declaration is guilty of an offence.

I give my consent for the NSW Environment Protection Authority to make inquiries and exchange information with local registration authorities in other Australian States and Territories or regions in New Zealand regarding my activities in the above-stated occupation(s) or activities or otherwise, regarding matters relevant to this declaration.
